MEETING CALLED TO ORDER: At 6:33pm, A pledge of Allegiance to the Flag was said by all.

Clerks Minutes: Clerk needs to change Bills last name to Simpson and the date is March and not April. Clerks Minutes accepted, Ecklin made a motion to accept, Haley made the motion to carry.

Treasurers Minutes: General fund: \$403,131.24 Rubbish: \$83,553.07 and Roads: \$635,622.92, ARPA: \$12,340.26, Check for BS&A \$7340 will be coming out of Arpa account. Which it will leave ARPA with \$4800.26, Sandy is still waiting for the county with the tax delinquent. Ecklin made a motion to accept the Treasurers Report, Haley second. Motion carried
New Business:

Trustee Ecklin let us know that Brine went up to .29 cents a gallon from last year which was .18 cents. First Brine is May 19th. Caleb had a complaint about one of the pools at a repo house on Meredith Grade, it is full of water and is attracting a lot of mosquitoes. And a house on Rodgers has two cars by the road that is getting picked apart, he just got the complaint so he will be reaching out to the owner to see about moving the cars. Margret said that they don't have anything to report, Roy got a new truck a year or so ago and he loves it, everything is going well. Erie asked about if we decided what we are going to do with the fire, for right now we have not decided, we are good for fire protection until December 2023. Clerk is going to call another fire department to set up a meeting with Ed and Caleb. We explained what would happen if we do not have fire protection. We have never been without fire protection. Arnold lake Road is going to be started sometime in May. Commissioner report on the election consolidation, they decided to change things up from what they do normally, the county is going to cover the cost for the 2024 election. After 2024 they will look at it again to see if they will change it. The county is adding more cameras, paid with grants and Arpa funding. Jerry Becker is looking to have a township spill ordinance he will be emailing us copies. Haley made a motion for Clerk to go with the county election consolidation. Ecklin second it, motion carried. Supervisor Erskine signed the contract with the equalization and we went with option 3. Clerk will mail the contract to equalization.
