County Commission; David Hoefling; The Airport committee obtained a grant for repairs to the Harrison Airport. The county commissioners have tabled the money unsure if they want to accept it. The commissioners will decide at the May meeting if they are going to close Harrison's airport or not. May 17th there will be a fly in from 8-11 am at the airport. Clare County Sheriff's department will be getting some new patrol cars.

Blight; Caleb is working on the ordinance for hazardous spills. The zoom ordinance needs rewritten as that a large portion of it does not pertain to Franklin twp. We need a code of civility for zoom. A motion was made by Haley to publish said ordinances in the paper followed by a meeting to vote on them. Second by Ecklin. Motion passed.
