Ed asked about Rodgers and overlay and was told overlay would crack and they will keep an eye on it. Jackie asked about paving in cold weather and was told he made the call to gravel it. Tom K. asked about Meredith Grade and gravel. Crown is disappearing and they will let the driver know. Easy fix for the grade and Claroskee. Dick Ecklin voiced concerns over getting gravel into the hollows on the grade. Southshore Drive is private and wants county to maintain. They can't but twp can help with making arrangements to bring dumpsters to corner. Discussion on rubbish trucks being front or side loaders. Cathy Gilliam mentioned approach from 18 onto Claroskeeand on behalf of Bill Walters says N. Athey still needs work by his house. Dick Ecklin says trees need work on the grade, road commish says they have 66' of right away and cleared by prority. Ruey Wood wants to know about speed study for Elbow Lake area.
