The county is looking into not having to have a buffer zone for the spongy moths, it is 600 feet now. They are thinking of seeing if they can get it down to 150 feet. The county's insurance went up four 400 thousand. Airport will not be having any more races due to liability issues. They are looking into different places they can have them. Hays township is charging they 2500 for a permit to do the races. Bill- Stockwell started this week, will be class a road, they are getting complaints it's a 55mph road it will stay 55 mph. The Masteller bridge is now open. Caleb- complaint on Evergreen, they are fixing it up, and there is a pile of old wood was the only thing sitting around. It's only been there a week. Caleb went there Monday and they weren't there. The board said that a week isn't a big deal, if it stays longer that that we will deal with it. He went out to woods roads and there is a gate but he wasn't sure If it was on the road part or not, Ed said he would go out and take a look. Erie High, he went and looked at a house on woods road that is up for tax sale and people confronted him with an AR15 and there was no yellow for sale sign. The streetlight is still blinking, clerk will call and get them out again. Clerk announced the poll workers, Jackie Ecklin (Rep) Therese Haley (Dem) Alexa Cooper (Rep) and Shelly Schultz (Dem). Sandy made a motion to raise clerks' mileage to \$1,500. Ecklin second it, all in favor, motion carried. We also talked about West Bay with them not paying their taxes.
