Motion to do maintenance gravel off Cornwell by Erskine 2<sup>nd</sup> by Scherrer. Motion passed.

There was a discussion about upgrading Woods to full gravel. Twp needs to look into roads that need to be graveled. Will revisit this in July.

Community discussion regarding the Hall rental and how it affects community game night. Motion to leave the fee as it is until July by Haley 2<sup>nd</sup> by Ecklin. Motion passed.
